


Investabili ETR® are fixed value Exchange Traded Receivables that are leases, monetary obligations or Bills issued under Contract for assets, goods and services supplied to investment quality⁺ companies, or credit insured invoices from Investment Grade [IG] insurers. As at M02, Credebt Exchange® held Active RSA of EUR 25.44m, with EUR 24.24m fully allocated. Investors redeemed EUR 0.76m in the period and trading for M02 was EUR 9.36m+ with all ETR utilised.

Treasury performance at EUR 6.23m of settled ETR was noticeably below the trade for the month. This imbalance can be attributed to a significant increase in trading for the month.

Yield average increased to c.1.978% in the month starting at 1.952% and ending on 1.919%. This stabilised price is expected to increase in Q2/Q3 in line with Originator supply. The slight decreases in the Credebt® Index and increase in supply from Originators should see this figure remain constant until Q2/Q3. Available RPA was EUR 25.44m+



Performance

2020-M02 v 2019-M02 showed a decrease in trade volume of 25.13% but a significant trade value increase of 39.69%.
